

ALIEXPERSS I&M BANK CAMPAIGN TERMS & CONDITIONS

Effective Date: 7th July 2025

1. Scope

The following terms and conditions (the "Terms and Conditions") apply to the AliExpress I&M Bank Campaign. By participating in the Promotion, you will be deemed to have read, understood and accepted these Terms and Conditions.

- 2. Payment Discount Campaign Period (the "Campaign Period")
 - Initial Campaign Period: The discount is initially valid from 00:00 AM (Kenya local time) on 7 July 2025, to 23:59 PM (Kenya local time) on 7 September 2025.

3. Promotion Mechanics

- Promotion Structure: "Instant Off" means the immediate reduction in the total payable amount during checkout when payment is made using an eligible I&M Bank Mastercard card. "Minimum Spend" means the actual payment amount threshold that must be reached to trigger the discount.
- Discount Offer: USD 20 Instant Off with a Minimum Spend of USD 40.

4. Eligibility Criteria

The instant off offers (the "Promotion") is available with listed conditions:

- The offer is valid for I&M Bank Mastercard cards with the following BINs: Consumer Prepaid (555493), Debit Platinum (547743), World Debit (558252), World Credit (555458), and the Debit World Elite (553540).

- The offer is applicable only when the ship-to address for order made on AliExpress app or website is located within territory of Kenya.
- Discount offer is subject to availability, offer available on a first come, first served basis for eligible cardholders.

- Each user can redeem Instant-Off up to 3 times each, during the Campaign Period.
- Users can apply up to one type of Instant Off on single transaction.
- The Instant Off can only be applied when the actual amount paid, after all other discounts have been used, meets the corresponding Minimum Spend Threshold, and all conditions for using those discounts are met.

7. Redemption Process

The Instant Off shall be automatically applied at checkout when using the I&M Bank Mastercard cards, if eligible.
