Headquartered in Dar es Salaam, I&M Bank is a subsidiary of I&M Group PLC which is listed on the Nairobi Stock Exchange and has a growing regional presence currently also extending to Mauritius, Rwanda, Kenya and Uganda. It is licensed by the Bank of Tanzania. The bank started operations in Tanzania in 2002 as CF Union Bank. In September 2010, the bank changed its name from CF Union Bank to I&M Bank (Tanzania) Limited, to reflect the new ownership. Now the bank operates in major cities including Dar es Salaam, Arusha, Mwanza and Moshi with plans to extend to other regions.







Treasury

Spot FX

With financial partners located throughout the globe, we buy and sell over thirteen global currencies in the spot market in order to meet market needs of both retail and corporate clients. Furthermore, our Group strong presence in East Africa enables us to cater for cash foreign exchange transactions for walk-in customers (non-account holders) at a zero cost at any of our branches across the country. At the same time, we offer special and negotiable rates for amounts above USD 5,000.00 or the equivalent in other currencies.

Forward Transactions

We facilitate execution of contracts which allow customers to buy or sell one currency against another at a future date i.e. a date more than two days from the deal date, at a predetermined price. With this arrangement customers can hedge against the impact of exchange rate and interest rate fluctuations in the spot market by agreeing with I&M Bank to fix a future rate in advance.

Foreign Exchange Swaps

Our Foreign Exchange (FX) Swaps allow customers to exchange two currencies at an agreed rate on a specified value date and at a later date swap the currencies at a pre-agreed rate. It gives flexibility to corporates to optimize the use of cash flows of different currencies.

Fixed Income (Bond Trading)

We trade securities in Secondary market, where brokers can have opportunities to receive competitive return on their investments when buying or selling to the bank.
